April will be a busy month for the branch as we are hosting the AAUW of Michigan 96th Annual Meeting and State Convention at the Summit in Canton on April 28th. We are excited to share our leadership with the rest of the



AAUW-Michigan members and look forward to showcasing the branch and the area. While we have many members who are attending and supporting the activities of the day, there's always room for more to come and enjoy the day -- and it's right in our own backyard.

Members coming from a distance will be staying at the Sheraton at Metro Airport. Because it is the same weekend as commencement at U-M, rooms in Plymouth and Canton were reserved for that event. On Friday, April 27th, the AAUW-MI State Board will arrive and hold their Board meeting at the Sheraton. Later that evening there's a reception at the Sheraton which includes the viewing and discussion of a movie on equality. There will be cash bar and hors d'oeuvres.

On Saturday, a full day of speakers and discussions at the Summit is planned. The keynote will be delivered by Barbara McQuade, current U-M College of Law professor of practice and former U.S. attorney general for the eastern district of Michigan. Other sessions include a panel discussion on the theme of the convention; #What Now, and another on the gender pay gap; an update from the national association; and, an update on Public Policy and Research. Following lunch there will be a business meeting and awards, along with an update from the Student Advisory Council panel.

Registration for Saturday is \$120 and the branch will reimburse you one half of that fee (\$60) for up to 20 members who attend. You can also get more information and register using the forms in the state AAUW newsletter that came to your home last week. I have attended these meetings while I have been president and I find them interesting and enjoyable. I always learn something new! Hope to see you there.

EQUAL PAY DAY

This year Equal Pay Day was commemorated on Tuesday, April 10th. Equal Pay Day symbolizes how far into the year a woman must work on average to earn as much as a man earned the previous year. (Tuesday is the day on which women's wages catch up to men's wages from the previous week.) Because women earn less, on average than men, they must work longer for the same amount of pay. The wage gap is even greater for women of color

On April 10th the Michigan Equal Pay Day Coalition held a Lobby Training session and a rally on the steps of the Capitol. This group has a number of coalition partners with AAUW being one of the lead organizations. Attendees, dressed in red, also



visited the House Committee on Commerce and Trade morning session to strongly send a message that the pay gap must be closed and Michigan pay equity bills must be addressed. We were welcomed but not given a hearing to discuss Michigan's pay equity bills. After that we met with Republican legislators to discuss the wage gap and leave them with packets of information to elucidate them about this outreach. Upon sharing our experiences, we discovered that most of the legislators contacted did not believe that a pay gap exists in Michigan or the United States. These responses were not unexpected but still disheartening. However, at least we made our voices heard. At the rally on the steps of the Capitol we heard rousing speeches from some of our supportive legislators and an inspiring presentation by Deborah Gordon, a premier civil rights attorney in Michigan.

We all must continue our efforts to educate our communities about pay disparity and encourage hearings on the existing bills. At the glacial rate the pay gap is closing thus far, we will not see pay equity until the year 2119. This is not acceptable!!
