# From the President:

The Michigan AAUW Fall Leadership Conference was held on October 27, hosted by the Albion branch. Michigan was privileged to have in attendance Kimberly Churches, CEO of AAUW. Kimberly came to AAUW in June of 2017 from the Brookings Institution where she focused on

public policy organization, expansive partnerships, external relations, and advancement. Prior to Brookings, she had held management positions at the University of Denver, the University of North Florida, and the American Heart Association.

Those attending the conference found Kimberly to be energetic, focused, driven, and very approachable. She brought to her new position at AAUW her vision and problem-solving skills. In her first year, she and her staff met with, interviewed, and surveyed over 6,000



members and nonmembers with the intent of developing a new strategic plan for AAUW that would help move the organization into the future. The plan narrows the focus of AAUW to reduce possible redundancies within the organization and with other similarly focused organizations and to clearly define important initiatives and achievable goals.

Kimberly's message to all of us in that "Mission Matters" i.e. mission should be our focus. AAUW is committed to a mission of advancing "equity for women and girls through research, education, and advocacy." Long-standing AAUW components, such as the Legal Advocacy Fund, the Eleanor Roosevelt Fund Award, and the awarding of funds and fellowships, will continue, but members will be able to participate in other focused projects that will help further the mission.

We all joined AAUW because we believed in the mission and we wanted to be able to further the mission to affect change within our community. The new AAUW will provide new opportunities to advance the mission that is possibly more important and definitely more achievable now than ever and to do so with research and support from our national organization. ## KNOW YOUR RIGHTS AT WORK

Even though many of us are no longer working, we have younger members that are and also children, grandchildren, and nieces that may experience inappropriate behaviors during their employment. Thus, it behooves us to be aware of sexual harassment issues in

the workplace. Sexual harassment is a form of sex discrimination that violates Title VII of the Civil Rights Act of 1964. Very generally, sexual harassment describes unwelcome sexual advances, requests for sexual favors, or other verbal or physical conduct. The behavior does not have to be of a sexual nature, however, and can include offensive remarks about a person's sex.

Title VII is a federal law that prohibits discrimination in employment on the basis of sex, color, national origin, and religion, and it applies to employers with fifteen or more employees. The law also makes it illegal to retaliate against a person because the person

complained about discrimination, filed a charge of discrimination, or participated in an employment discrimination investigation or lawsuit. It applies to federal, state, and local governments, as well as employment agencies and labor organizations.

Even with title VII's protections many people across the country still face sexual harassment in the workplace.

These publications will help employees better identify sexual harassment, advocate for themselves and others, and determine next steps.

We applaud all of the women and men, as well, that have shared their stories, especially during the past couple of years. The #MeToo movement has given people a voice and the courage to speak out. Let us continue to be aware and informed to assist those, who may need our empathy, support, and knowledge.
