One issue that is up for a vote again is the requirement of a university degree for membership. The proposal eliminates the need for a degree, opening membership to a wider group. One of the other proposals opens a few seats on the National Board to people who are not members of AAUW. The thinking behind this is that it would open the National group to input from other organizations with similar interests and advocacy. The third proposal deals with staggering the terms of board members. Please consider logging on to the website and expressing your views with your vote. The strategic plan is also available for review on the national website.

This commitment will give millions of women the skills they need to effectively understand their market worth and provide the tools of confidence to negotiate for it.


As branch members it is our responsibility to stay informed and committed to the above goals so that we are constantly in the process of moving our mission forward.

MEMBER NEWS

Bonnie Goodrich is a reading intervention teacher at Dodson Elementary School in Plymouth-Canton.

In November of 2016 my sister asked if my brother and I would like to get a team together to try out for Family Feud since auditions were going to be held at Cobo Center. We readily agreed and added in my niece and daughter to round out the team. (We later found out that my brother only agreed to try out as he was sure that we would never be on the actual show! Imagine his surprise when he was featured on their tv ads!) We used our family name, Wildt, for our team name. There were hundreds of people there auditioning. We did a trial game with another family and then were quietly asked to go into another room where we had a second interview and taping. Most teams were just thanked and sent on their way without this step. Near Christmas we found out that we were now considered an active family with the possibility of being on the actual show! By February I had to organize the team and submit dates that we were available to travel to Atlanta. This was not an easy feat with Allison, my daughter, working in Chicago and my niece, Becky, attending MSU! We waited and waited to hear more from the producers and finally in April of 2017 we got the call!

We were scheduled to fly out for Mother's Day weekend. The show paid for all our flights, transportation to and from airport, the hotel rooms and meals during our full day of taping. Meanwhile, we had very specific directions on organizing coordinated outfits, etc. We each needed to have 3-4 outfits! My husband and brother-in-law also joined us. The hard part was keeping our results secret for a full six months as the shows did not originally appear until Nov. 2107! No one could know how we did until the shows aired! Now we are showing up in reruns!

The day of the show we had to be there early for a "practice" session where the producers "ranked" the 7 teams to determine the order of appearance. We met people from all over the country as we were confined to a room and could not have any outside contact, take photos or use cell phones. Game shows are closely monitored to make sure that there is no cheating going on. They even accompanied us on bathroom breaks. All our meals were provided. They taped 4 shows in a day and we were on the 2nd, 3rd and 4th shows. It was a very long day as we had to be there by 9 a.m. and left about 10:30 at night. The crew taped the shows right after one another—two in the morning, a lunch break and then the other two. One audience group came for each half of the day. If we had gone on for another show, we would have been able to return to the hotel overnight and then would have been able to put on another outfit. That is why we had the same clothes on for all 3 shows! They taped about 1 1/2 hours' worth for each show and then reduced it down to the half-hour show with commercial breaks. A lot was edited out, including the introduction of our family members.

We really were not nervous as the producers and team made us feel so comfortable. We had practiced playing the game as a family, but it is MUCH different on tv! Doing the Fast Money Rounds was crazy! I am never going to live down some of my answers on the show. Pass me the BACON is already part of our Wildt family lore. I also made the Family Feud Hits of 2017 on YouTube with my Anchorage, Alaska answer. In all, we had a wonderful time as a family. We did win the \$20 thousand on the first show and then about \$100 each on the other two shows. We just got our checks in March! And as Allison wrote our team application, "It is not whether we win or lose, but the priceless family memories that we will share for years to come."
