News from National

National's website, aauw.org, provides members with the opportunity to let their legislators know their position on important issues. By clicking on Take Action, you will be brought to a page, or series of pages, called **Two Minute Activist.** Each page presents a national issue and AAUW's position on that issue and explains the rationale behind that position. By inserting your address or phone number, a message will automatically be sent to your senator or representative voicing your support or opposition. You can send a message written by AAUW or one of your own. You can also sign up for automatic alerts when advocacy is needed.

Current issues posted are: Judge Kavanaugh's confirmation; the Dream Act; Title IX; the Higher Education Act reauthorization; and public funds for public schools.

23rd Amendment residents of the District of Columbia (Washington, D. C.) may vote for president of US

24th Amendment | poll taxes abolished; no poll tax stopping citizens from exercising right to vote
