## AUGUST 26 TH : WOMEN'S EQUALITY DAY

As you know, Women's Equality Day celebrates the ratification of the 19<sup>th</sup> Amendment, which gave women the right vote. On Saturday, August 24<sup>th</sup>, AAUW of Michigan and a number of other supporting organizations gathered to honor our foremothers and their sacrifices and also to review the status of the ERA. In addition, a panel of women, including Dr. Kimberly Andrews Espy, the first woman president of Wayne State University, and two of her colleagues engaged us with their personal journeys in the world of academia. An ardent and life-long supporter of the ERA, Laura Callow, known as the Susan B. Anthony of Michigan, was honored by all ninety attendees. Patricia Rayl, AAUW Jackson, updated us on the state of the ERA. Several Plymouth-Canton members were in attendance.

The Equal Rights Amendment, first proposed in 1923, is an amendment to the U.S. constitution that guarantees equality of rights under the law for all persons regardless of sex. As of January 2020, the ERA satisfied all requirements for ratification. Leading constitutional scholars agree that the ERA is now part of the Constitution. However, the Archivist of the United States has not yet taken the final step in terms of certifying the ratification of the 28<sup>th</sup> Amendment.

Attention now turns to the Senate and moving S.J. Res 1 to the floor for a vote that will remove the time limit, thus making the 28<sup>th</sup> Amendment part of our Constitution. It has been over a hundred years, and that is unacceptable!! Please contact the White House and let them know that it is time that equal rights for women should be solidified in the Constitution.
