As you know, AAUW promotes gender equity for all women and girls through research, education, and advocacy. We are strong supporters of public education, which has been the bulwark of or nation since the 1800s. Now our system is under attack, as Linda McMahon emailed her staff to prepare for their "final mission," dismantling the Dept. of Education. Even though President Trump paused the release of the order after considerable blowback, most likely the efforts will continue.

The U.S. Department of Education originated in 1867 and has been responsible for upholding civil rights and ensuring equal educational opportunities. Without it we face support for public school vouchers, stripping of federal funding from public schools, and saddling millions of borrowers with a lifetime of debt. The well-being and safety of students will be put at risk as they may face more gender-based harassment, discrimination, and violence.

## **ELECTION TIME – FOR OUR BRANCH**

At the annual branch meeting in May, we will elect three officers: Vice President of Finance, Vice President of Membership, and Vice President of Program.

This is the job description from our Bylaws:

The Vice-President of Finance shall be responsible for collecting, distributing, and accounting for the funds of the branch. The treasurer shall collect dues and properly remit them to the association and state by the specified deadline. Gail has been the treasurer for 2 years, and she describes that the job can average up to 8 hours a week. Specific tasks include preparation of the annual budget, preparing the books for external audit, and preparing the monthly financial reports for the board and the branch meetings.

The Membership Vice-President shall invite potential members, handle applications, and supervise renewals. Two things are different now. First, people can join or renew themselves online using a credit card. When people do that, the membership chair works collaboratively with the treasurer to make sure that records are accurate and up to date. Second, members renew on the yearly anniversary of when they joined. So, throughout the year, there is a rolling renewal process, rather than renewing the whole branch in June.

*The Program Vice-President shall oversee the programs for branch meetings*. Please Note the word "oversee". No one expects this VP to plan all the programs and line up speakers. We have a meeting in July or August at which plans for the coming year are made. Different members accept responsibility for contacting speakers.

### Would you please consider how you can be active in the branch? Would you be willing to serve on the board? Would you be willing to be a **co**-officer working with someone else?

For many people, one meeting a month is one too many. But for several of us, the board meeting is a nice get together with friends, good food, and a way to be more involved in the branch's activities. If you think you might be interested, but want to know more details, please call the officer who now holds the position.

It is very uncommon for any officer to be overwhelmed with the work. There's always someone willing to lend a helping hand.

### News from AAUW National -

The AAUW Board approved a modest dues increase  $-\frac{2}{2}$  per year over the next two years.

New national dues: \$74 starting April 1, 2025, and \$76 starting April 1, 2026. The Board's decision to increase dues by \$2 reflects an adjustment to the original proposal (which was \$5 per year for 5 years) to lessen the burden of a dues increase on members while keeping pace with inflation. State (\$15) and Branch (\$10) dues remain the same for a total of \$99 for 2025.
